



Dear NYSARH Members and Friends,

I want to take this opportunity to recognize the extraordinary circumstances you have faced in recent weeks battling COVID-19 and, on behalf of NYSARH, I want to thank you for your unwavering dedication to the health and safety of our rural communities.

Many of our members are essential workers on the front line serving those infected by the novel COVID-19 virus and/or continuing to care for the injured, sick, and most vulnerable. Others are on PAUSE and working from home to keep services and programs operating smoothly so residents have resources to meet their families' needs.

During these times, NYSARH is here to support your efforts and continues to work on your behalf:

In January and February 2020, NYSARH sent its largest delegation to date visiting both Albany (22 delegates with 20 visits) and Washington, DC (8 delegates with 12 visits) to meet with elected officials about policy and fiscal issues facing our rural communities. A new Policy page has been added to the NYSARH website and we invite you to visit regularly to stay abreast on rural health issues. A special thank you to Committee Chair Barry Brogan, NYSARH Strategic Development Director Sara Wall Bollinger, and NYSARH's Administrative Team for leading our advocacy efforts.

NYSARH continues to administer the 2019-2020 Legislative Appropriation Award championed by Senator Rachel May (D-53rd) supporting 32 Rural Health Networks and 44 Rural Access Hospitals. Funding was distributed to the organizations under the guidance of the Charles D. Cook Office of Rural Health with the purpose of supporting services to rural residents. We look forward to sharing results of this Initiative on our website and in future Newsletters.

NYSARH welcomed twenty-four (24) new members since October 2019, thanks to the efforts of the Membership Committee led by Charlotte Crawford, Chairperson. A Student Membership study continues in order to advise NYSARH on how to better engage our student members. We look forward to sharing the study results in an upcoming Newsletter.

As New York City became the epicenter of the COVID-19 pandemic and Senators and Assembly members tested positive, legislative leaders and members of the Governors' staff continued to negotiate details for the 2020-21 State Budget. The budget was passed in the wee hours of April 3rd with an estimated revenue gap of \$6 to \$15 billion. The Governor may amend the budget based on actual revenue three times during the year. Each time he does so, the Legislature will have ten days to come up with a better plan. If they don't, the Governor's plan will be implemented. Read more. . .
