Barry took roll call and welcomed attendees at 9:02.

1. Motion to accept the notes of October 22<sup>nd</sup> [Anne Marie/Courtney] passed.
2. Identify themes and priorities from Member Survey and other Input.
  - Consensus that the Rural Lens is our main message
  - There are too many ideas; the Committee will prioritize a few for effective advocacy efforts via a Survey
  - We will try to make a distinction between *regulatory* issues that require advocacy with the Departments of State government and *legislative* issues that require new laws to be adopted

### Actions:

- a. Sara will send the multi-logo letter that was sent to the Governor re: flavored tobacco to Committee members
  - b. Sara will ask NRHA to send info re: the Senate Rural Health Package and then forward this to the Committee members
  - c. Liz will find and share HANYS position statement on the NY Health Act as well as who are the major proponents of the NY Health Act, A5248/S3577.
  - d. **Who** will find and share the 'plain language briefing' **on what**
3. Partner Organization issues

    - a. Sara will follow up with the Social Worker Association re: if they have language from the Governor's veto message
    - b. Sara will follow up with the Home Care Association re: legislative language enabling Community Paramedicine
    - c. Liz will send language from HANYS regarding Community Paramedicine

4. New York State Budget

There are reports of a \$4+ Billion deficit. The Executive Budget will likely reduce funding to several programs. The Medicaid Budget Cap was breached last year, but was hidden by games. This year it cannot be hidden. Possible Medicaid cuts across-the-board to providers. The prospects for a good COLA are slim.
